#### ACTING

The former, in his capacity as Managing Director, on behalf of the trading company TALONOTEL, S.A. (hereinafter, "TALONOTEL"), with Tax identification Number A-84431782 and retail/wholesale Travel Agency licence number CICMA-1747, whose registered office is in Pozuelo de Alarcón (Madrid), Paseo del Club Deportivo, number 1, Parque Empresarial La Finca (Edificio 13, Derecha 2), incorporated for an indefinite period by means of the Memorandum authorised by the Notary of Madrid, Mr. Jesús Roa Martínez, on 23 August 2005, with number 1.345 of his protocol. The company is registered at the Companies Registry of Madrid, volume 21.646, section 8, sheet 104, page number M-385324, registration number 1. For this act he makes use of the powers delegated to him in the aforementioned Memorandum.

Both parties, in the capacity in which they are acting, mutually acknowledge the other's proper legal capacity to execute this Contract and, for this purpose.

#### STATE

I.- That TALONOTEL, in its capacity as a wholesale/retail Travel Agency, has released on to the market a system of cheques, known as "Talonotel", which is marketed in a chequebook containing five cheques (hereinafter the Talonotel chequebook), with which the Users can arrange their stay in different hotel establishments, as well as, if applicable, special services which are shown in detail in the General and Special Conditions drawn up by TALONOTEL, which are listed in the Talonotel chequebook brochure.

II.- That the HOTEL states that it is interested in providing its services to the Users who agree to use the TALONOTEL system of cheques.

III.- That, having previously come to an agreement, TALONOTEL and the HOTEL have decided to regulate their relationship by means of this Contract, which shall be governed by the following

#### STIPULATIONS

##### FIRST.- OBJECT OF THE CONTRACT.

The HOTEL undertakes to provide its services to the Users, who have previously acquired the Talonotel chequebook, at a price previously agreed between TALONOTEL and the HOTEL, and to accept the Talonotel chequebooks as the means of payment for these services. All of this in accordance with the conditions regulated in this Contract, as well as the General and Special Conditions drawn up by TALONOTEL which are mentioned in the explanatory brochure for the Talonotel chequebook.

## SECOND.- TALONOTEL CHEQUEBOOK SYSTEM.

Without prejudice to the stipulations of the aforementioned General and Special Conditions, the system of payment with the Talonotel chequebook will be operated in accordance with the procedures described in this Stipulation.

1) The marketing of the Talonotel chequebooks shall be carried out exclusively by the intermediation of retail Travel Agencies, in accordance with the conditions agreed by each of them with TALONOTEL. These Agencies shall act on behalf of TALONOTEL, promoting and selling the chequebooks on behalf and on the account of TALONOTEL.

2) The Talonotel chequebooks are made up of five (5) cheques, which may be used by the Users as a means of payment in the different establishments which have previously agreed to provide their hotel services to TALONOTEL, always in accordance with the stipulations in the operating conditions for the cheques included in the General and Special Conditions of TALONOTEL.

THE HOTEL is obliged to accept the number of cheques which are specified in Annex 1 of this Contract as consideration for the daily use by the User of a double room, for one or two people, reserved in advance (directly by the User, by a retail Travel Agency or by TALONOTEL) on any of the dates indicated on the calendar which is attached to this Contract as Annex 1.

In addition, provided that there is availability at the time the reservation is formalised and that this has been requested by the User, THE HOTEL will provide, at no additional cost to the User, a cot and/or extra bed in the same bedroom, for a maximum of two children under twelve years of age.

3) Each of the cheques in the Talonotel chequebook will have a monetary value, established in Annex 1 of this Contract, which includes the amount for the accommodation services provided by the HOTEL, and the Value Added Tax applicable for the provision of this service.

Any other charges, taxes, additional services or supplements that the HOTEL may provide to the User during their stay in it shall be excluded from the amount of each cheque, as these may only be paid for directly by the User to the HOTEL, irrespective of the payment for the accommodation services and the extra items exceptionally arranged with the Hotel by means of the Talonotel chequebook.

4) If the User, in accordance with the General and Special Conditions of TALONOTEL, has made a reservation at the HOTEL, the latter is obliged to accept cheques from the Talonotel chequebook from the User, as well as to guarantee the validity of the reservation until 6 p.m. of the check-in day.

5) If the User wishes to guarantee their reservation after 6 p.m., they may do so by calling the hotel directly, it then being at the discretion of the hotel whether or not to ask for some kind of deposit, or by calling TALONOTEL, in which case it will be necessary to provide the credit card number to guarantee the reservation. TALONOTEL will then proceed to send the HOTEL the credit card number provided by the User.

In the event of a reservation being cancelled, or the User failing to appear at the HOTEL on the date reserved, the HOTEL shall not be entitled to claim any payment for cancellation costs or compensation for these items.

The possibility of providing its services through the use of the Talonotel chequebook will be at the discretion of the HOTEL should the User wish to make use of these without having previously formalised a reservation at the HOTEL, or if they should wish to use cheques on dates other than those which have been validly accepted by the HOTEL at any time. Notwithstanding the above, once the use of the cheques has been accepted by the HOTEL in the aforementioned cases, the regulations contained in this contract and in the General and Special Conditions detailed in the brochure shall be applicable to the cheques.

6) In the event of the reservations at the HOTEL being made directly by TALONOTEL, the latter will have rooms available without the need to make a prior request for availability to the HOTEL, provided that these reservations are made within the available dates agreed between the parties.

7) The reservation can also be made in two ways:

7.1 By the User or a retail travel agency directly with the hotel.

7.2 By the User or a retail travel agency through Talonotel. In this case, TALONOTEL will send the reservation to the hotel by fax or email.

The HOTEL will accept the Talonotel Chequebook Exchange Listing as the only valid document for the exchange of Talonotel chequebooks. TALONOTEL will send this Listing to the hotel by fax or email prior to the arrival of the User.

Any other document which may be presented by the User on their arrival at the hotel, shall be deemed to be a presentation voucher for the purposes of providing the User with information, and shall not be valid for the exchange of Talonotel chequebooks. Under no circumstances may the HOTEL give the User individual cheques.

For this purpose, the HOTEL shall keep a stock of chequebooks, on deposit, and on the account of TALONOTEL, and only these may be exchanged with the Talonotel Chequebook Exchange Listing sent to the HOTEL.

Custody of the stock and its correct use will be the exclusive responsibility of the HOTEL. The HOTEL shall therefore be liable for the removal, loss, damage or transfer of the chequebooks in stock, and may not in these cases claim any amount from TALONOTEL.

The HOTEL may not transfer the Talonotel chequebooks which it has in stock to third parties, or even other HOTEL, without the express written authorisation of TALONOTEL

The HOTEL will be responsible for requesting from TALONOTEL new chequebooks as those in stock are used. Stock replacement orders for chequebooks shall be made sufficiently in advance to enable TALONOTEL to deliver them to the HOTEL within the required time.

Within the 15 days immediately following the end of the validity period indicated in Annex 1, the HOTEL shall forward to TALONOTEL all the complete Talonotel chequebooks it has in stock which have not been used by the Users.

If the total number of chequebooks exchanged at the HOTEL for the Talonotel Chequebook Exchange Listings and the number of chequebooks not used and returned within the period indicated in the previous paragraph do not agree with the total number of chequebooks held in stock at the HOTEL, it shall be deemed that the latter have been used directly by the HOTEL or made available to its employees. They shall therefore be settled in the same way as if they had been acquired by a User, applying in this case the discount to the HOTEL indicated in Annex 1.

If the HOTEL is required to pay TALONOTEL for the amount of Talonotel chequebooks, these chequebooks will be invoiced at the price stipulated for the Users, with the discount which is indicated in Annex 1. Once the origin of the settlement of the aforementioned chequebooks has been verified by TALONOTEL, the HOTEL expressly authorises TALONOTEL to offset the amount corresponding to these when making the next payment to the HOTEL, in accordance with the provisions of this stipulation.

8) The validity period of the cheques will be that established in Annex 1 of this Contract.

9) The use of the Talonotel chequebook shall not be valid for groups. For the purposes of this Contract, groups shall be deemed to be reservations made for more than 5 bedrooms.

10) Once the validity period of the Talonotel chequebooks indicated in Annex 1 has ended the HOTEL may under no circumstances accept these cheques.

11) The acceptance by the HOTEL of the use by the Users of the Talonotel chequebooks shall not in any way affect the quality, equality and transparency of the services provided by the HOTEL with regard to the category which it is assigned at any time or the other Users of the hotel.

Any claim by a User regarding the improper provision of the services by the HOTEL will be the exclusive concern of the latter; and TALONOTEL shall be expressly exonerated from any liability resulting from these claims, whether they result from the rulings on proceedings commenced by the competent official organisations for tourism and hotel matters or by the courts of justice.

12) TALONOTEL will be responsible for carrying out promotional activities for the Talonotel chequebook and the hotels which have agreed to provide it with their hotel services. The HOTEL expressly authorises TALONOTEL to include the information previously provided by the HOTEL in any promotional or advertising material which may be published by TALONOTEL.

13) The HOTEL undertakes to TALONOTEL that the price agreed between the parties for the HOTEL services which form the object of this contract will be kept as the best prices offered by THE HOTEL for similar services as those rendered by virtue of this contract.

### THIRD.- CONSIDERATION BETWEEN THE PARTIES.

Once a fortnight, the HOTEL will send TALONOTEL the originals of all the TALONOTEL cheques handed over by the Users as consideration for the services provided. The HOTEL will also send the following documentation:

- Talonotel settlement form: a document where the HOTEL reflects the number of cheques which are sent to us for their payment. This settlement form should be linked internally in the hotels to the invoices or reservations whose cheques are sent to us for payment.
- The invoices for the reservations of Users who have agreed to use the Talonotel chequebook.

Notwithstanding the above, in the event of the HOTEL, in accordance with the invoicing criteria and conditions established in Royal Decree 1496/2003, of 28 November, by which the Regulations governing invoicing obligations were passed, and the Value Added Tax Regulations were modified, expressly authorises TALONOTEL to issue the corresponding invoice on its behalf, with a specific serial number and correlatively numbered. It will not be necessary to send the invoices to the TALONOTEL offices.

- All the Talonotel Chequebook Exchange Listings, where for each client the HOTEL lists the chequebooks handed over to clients who should have picked up chequebooks from the hotel.

TALONOTEL will pay the HOTEL the amounts which correspond to it by virtue of that which is established in Annex 1 of this Contract. The HOTEL having sent TALONOTEL the originals of the cheques shall be an essential condition for proceeding with this payment.

The payment of the amounts referred to in the previous paragraph will be made between the 5th and 20th of each month. Cheques received in the first fortnight of each month will be paid on the 10th of the following month and those received in the second fortnight on the 25th of the following month.

All the payments to be made by TALONOTEL to the HOTEL will include the amount of the services agreed between the parties, plus the amount corresponding to Value Added Tax.

Within the fifteen days immediately following the end of the validity period indicated in Annex 1 the HOTEL shall forward to TALONOTEL those cheques which have been used and are still to be settled in order to proceed with their payment. If this is not the case, TALONOTEL shall not be bound to pay the cheques which are received outside of the stipulated period.

The HOTEL shall also send TALONOTEL a certificate showing that it is up-to-date with its tax obligations, in accordance with the criteria established in the General Taxation Act.

#### FOURTH.- DURATION OF THE CONTRACT.

This Contract shall begin to take effect on the day it is signed.

The duration of this Contract will be for one Campaign. For the purposes of this contract, the Campaign shall be deemed to be the validity period of the Talonotel chequebook, and will be renewed from one year to the next, by tacit renewal, unless this is expressly waived by either of the parties, in a reliable manner, one month in advance of the expiry of the first period or any of its extensions.

#### FIFTH.- CONFIDENTIALITY.

The parties undertake to maintain the confidentiality of all the documents and information that they handle as a result of the execution of this Contract throughout its duration, or that of any of its extensions.

In particular, both parties undertake:

- 1) To maintain as diligently as possible the confidentiality of the information which, as a result of the execution of this Contract, may be used by each of the parties with third parties unrelated to this Contract.
- 2) To maintain the confidential information in a secure and strictly confidential manner, adopting the measures necessary to guarantee that it is only provided to employees who are required to undertake the corresponding work and on the premise that they need to be familiar with it.
- 3) Not to copy, reproduce or use the confidential information for purposes not included in the fulfilment of the obligations resulting from this Contract.

#### SIXTH.- TERMINATION OF THE CONTRACT.

This Contract may be terminated by the parties for any cause of breach by the other party of the obligations contained therein.

Termination of the Contract in the event of breach by one of the parties will take place without the need for any action other than the written notification of the non-breaching or breaching party, with a notice period of one (1) month, indicating in this notification the cause of breach of the contract.

As an exception, the parties may terminate this Contract unilaterally, without being required to pay any amount as compensation, except for the amounts which, if applicable, are still to be settled by them as a result of the normal execution of the contract, up to the effective termination date, provided that notice of at least three (3) months has been given.

#### SEVENTH.- MODIFICATION OF CONDITIONS.

Every year the parties will agree the possible modifications to this Contract. The validity of the remaining unaltered Stipulations shall not be affected as a result.

All modifications to this Contract, as well as the conclusion of additional agreements added to it, shall be in writing.

Notwithstanding the above, whilst the contract is in force, the HOTEL may unilaterally and exclusively modify the calendar for the provision of its services to the Users of the Talonotel chequebook, and shall be required for this purpose to advise TALONOTEL of these changes preferably by using the computer system or, failing that, by fax. The validity of changes notified regarding the available dates for the use of the TALONOTEL cheques by using the computer system will take effect immediately. The validity of changes notified to TALONOTEL by fax / email will take effect two (2) hours after the receipt of the aforementioned fax / email, and the HOTEL shall be bound to accept all the previously confirmed reservations until the above-mentioned changes become valid.

**EIGHTH.- DATA PROTECTION.**

In the execution of this Contract both parties shall be bound to comply with the current personal data protection regulations, particularly Act 15/1999 and Royal Decree 994/1999, by which the Regulations for Security Measures for automated files containing personal data were passed, and undertake to adopt all the security measures required by these regulations.

If in the execution of this Contract either of the parties is required to provide third parties with personal data included in their files, the party transferring this data shall have the prior, express and unequivocal consent of those affected by this transfer, informing them of the recipient or purpose of the notification.

Both parties shall be bound to hold the other party harmless from any claim or penalty which may be caused as a consequence of a breach, by them or by those who act or have acted on their behalf in any phase of the processing of personal data, of the obligations established in this clause or established by the personal data protection regulations.

**NINTH.- NOTIFICATIONS.**

All the notifications required to be made by virtue of the stipulations of this Contract, shall be made in a reliable manner, to the residences designated in this contract.

If, whilst this Contract is in force, any of the parties wishes to modify the residence indicated above for the purposes of notifications, both parties undertake to notify the other in a reliable manner of this circumstance.

**TENTH.- INTEGRATION OF THE CONTRACT.**

In the event of some or all of the provisions of this Contract not being valid in accordance with the law and/or being impossible to carry out, as well as in the event of a loophole being detected in the regulations as a whole, the effectiveness and validity of the remaining contractual provisions shall not be affected as a consequence. In this case, the contracting parties shall be bound, either in replacement of the invalid and/or irrelevant provisions, or in order to fill the loophole in question, to draw up regulations which –as far as possible- approach the spirit and purpose pursued by this Contract.

**ELEVENTH.- JURISDICTION.**

The parties, expressly waiving any other jurisdiction to which they might have recourse, submit themselves to the jurisdiction and competence of the Courts and Tribunals of the city of Madrid.

In witness whereof, both parties sign this document in duplicate and for a single purpose, on the date and in the place shown in the heading.

## ANNEX 1

- 1) The Talonotel chequebook will have the following validity period: 1 April 2007 to 16 March 2008.
  - 2) The number of Talonotel cheques which the User shall hand over for the daily use of a double room, for one or two people, will be those established in the Acceptance Calendar for 2007-2008.
  - 3) The number of extra beds made available to the programme will be:
  - 4) The TALONOTEL chequebook consists of 5 cheques and the monetary value of each Talonotel cheque will be 60 Euros, since the sale price of the Talonotel chequebook to Users will be 300 Euros, including VAT.
  - 5) For the provision of its services to the Users, TALONOTEL will pay the HOTEL the amount of \_\_\_\_\_ for each Talonotel cheque, plus the amount for Value Added Tax.
  - 6) The Talonotel chequebooks which, according to the provisions of the Second Stipulation, section 7), must be paid by the HOTEL to TALONOTEL, will benefit from a discount on the sale price for Users, this price being set at the amount of 264 Euros, including VAT.
  - 7) THE INDIVIDUAL VALUE OF EACH CHEQUE shall entitle the User to a double room for one or two people. If required by the user, an extra bed or cot will be provided for a maximum of two children under the age of 12 subject to availability in the hotel.
  - 8) The duration period of this contract shall be from the date of its signature until the end of the Talonotel 2007-2008 Campaign, and shall be renewed in accordance with the stipulations of clause 4th of this contract.
  - 9) We remind you that once they have been completed, two copies of this Contract must be duly signed, stamped and sent to our offices. A copy signed by Talonotel will then be sent to you by post.
  - 10) All black out dates, openings or modifications on Free Sale will have to be made through <http://ho.talonotel.com> or forwarded by fax to this number 91 838 53 25 exclusively. Any action not made through these channels will not be considered like valid.
  - 11) The hotel is committed to participate with TALONOTEL in the expenses of publicity, promotion and maintenance of the data provided by the HOTEL for the commercialization of its hotel services with an annual fixed amount of 300 Euro. This amount will be discounted of the first settlements that the hotel sends to TALONOTEL.
  - 12) All personal data that THE HOTEL may have submitted to TALONOTEL shall be incorporated to a database pertaining to TALONOTEL and its finality will be to maintain and manage your data as a user of the services provided by TALONOTEL and companies pertaining to TALONOTEL Group, to promote activities and services that are provided or could be provided in the future by TALONOTEL or. This information may be used only for the purposes of maintenance and management of the data by virtue of this contract, and also for promotional and information purposes that could be of the interest of THE HOTEL.
- TALONOTEL undertakes to apply all the security measures to protect all the data submitted by THE HOTEL, according to Spanish Law 15/1999 of data protection, THE HOTEL may request the cancellation and modification of the data, by notification in writing to TALONOTEL, Paseo Club Deportivo, 1, Edificio 13, Pozuelo de Alarcón, Madrid.
